Minutes of Great Bealings Parish Council meeting held by video conference at 6.00pm on Thursday 3rd September 2020

1. Apologies for Absence

Apologies were received from Colin Hedgley, Rob Munn and John Carter-Jonas

2. Declaration of Members' Conflicts of Interests in any items on this Agenda There were no declarations

3. Minutes

The minutes of the meeting held on 7th July were approved for signature, subject to the following amendments:

4. Delegated Powers

Following the success in holding virtual meetings, CPB proposed that the delegated powers currently held by the Clerk be revoked. This was seconded by AS and agreed by Cllrs.

5. Planning Applications:

- (i) There are no new applications
- (ii) Updates on recent applications:

DC/19/4066 – Rosery Cottage Barn – The appeal has been allowed by the Inspector. CPB has written to the Head of Planning thanking him for supporting the PC in objecting to this application. MC raised the issues mentioned by the Inspector concerning the approach taken by ESC. It was agreed to send a letter to the appropriate Team Leader at ESC regarding the deficiencies in their objections submitted to the Inspector.

DC/20/1684 – 1 Rosery Cottages – Extensions and alterations – application permitted by ESC
DC/20/2215 – Lodge Road – Access – application refused by ESC
DC/20/2257 – Croft Cottage – Re-siting of new dwelling – application permitted by ESC
DC/20/1898 – Land to north of Lavender Cottage, Kiln Lane – Stable room and hay loft – application refused by ESC

6. Other Planning Matters

Following the complaint made to the PC which was discussed at the last PC meeting, a letter of response had been approved by Cllrs and sent by the Chairman to the complainant. However, the complainant was not satisfied with this and has made a further complaint direct to ESC.

7. Highways

(i) Boot Street – Extension of speed limit

Following conclusion of the initial consultation, SCC have proposed extending the 30mph limit further up Hasketon Road to cover all the properties. Cllrs were very pleased to approve this amendment. MC has received a message of appreciation from the residents of Hasketon Rd for the PC's persistence in pursuing this matter.

The funding deficit to be raised by the PC is £2000. Offers of donations have been received from some residents, the PC will contribute a sum from its reserves and an application has been made for some Community Partnership Funding which will be discussed at a meeting on 11th September which CPB will attend.

(ii) Quiet Lanes

This project has been resurrected by the Quiet Lanes Suffolk Group who will be applying for funding. The PC has nominated Rosery Lane and Hasketon Road to be included, and on recommendation from the Group our previous nominations of Seckford Hall Road, Lower Street and Grundisburgh Road will also remain on the list.

(iii) Other Highways Matters

MC has received an email from a resident about missing finger posts on some footpaths. The PC's Footpaths Officers MC and AS have investigated this and a report has been sent to ESC.
