1. APOLOGIES FOR ABSENCE

4. ELECTION OF OFFICERS

Mrs Sarah Cartwright was put forward for the position of Clerk/Responsible Financial Officer. Mr Eric Barnett proposed and Mr Ken Willcox seconded this proposal.

In her absence Mrs Emily Lynch was put forward for the position of Footpath Officer. Mr Julian Haywood-Smith proposed and Mr John Carter-Jonas seconded this.

The Chairman said he was happy to carry on as Village Hall Representative. This was proposed by Mrs Sally Johnson and seconded by Mr John Carter-Jonas.

Mrs Sally Johnson said she was prepared to carry on as Tree Warden. This was proposed by Mr Robin Sadler and seconded by Mr Julian Haywood-Smith.

5. APPROVAL OF MINUTES OF MEETING HELD ON 19 MARCH 2007

The Minutes of the Meeting held on 19 March 2007 were approved as a true and accurate record of the discussion at that meeting. The Minutes were then signed by the Chairman.

6. MATTERS ARISING FROM THE MINUTES

7. VILLAGE PLAYING FIELD - PROGRESS

Mr Julian Haywood-Smith gave a report on the parish playing field. The initial stage 1, of installing the zip wire had been completed and stage 2a was now well under way with the ordering and assembling of play equipment for the lower half of the field. Funding was at or about £100k which is two thirds of the total amount needed. The remaining £50k was hoped to come from the Big Lottery Fund and the parishes will know if the bid is successful by the end of July. All in all it was thought the play equipment would be up and running during the school holidays.

Stage 2b, levelling and building the multi-sports courts is also being commissioned now, and will be completed during the Autumn. Stage 3, is subject to the remaining funding. This comprises final landscaping and turfing of the football pitch, the circular bicycle path, and trim trail equipment.

A question was asked from the floor – "What is the position of funding for maintenance/running costs?" Mr Julian Haywood-Smith stated that this had been factored into the funding proposals, with some money already received for this very important aspect. The tennis court element will become an income generator with membership of a club paying to use these facilities. Volunteer members of the two villages were already engaged in overseeing regular inspection of the new equipment, under the supervision of the Village Hall Committee and Project Teams.

8. PARISH PLAN

Councillors were asked to nominate two representatives for the Steering Group. Mr Robin Sadler and Mr Paul Norris were nominated. Mr Robin Sadler was unable to attend the meeting on the 22nd May and for this Mr Julian Haywood-Smith agreed to attend.

9. MODEL CODE OF CONDUCT

A copy of the Model Code of Conduct along with a "Register of Member's Interest" was given to each of the Councillors to complete and read. In the mean time the Model Code of Conduct was adopted. Proposed by Mr Ken Willcox and seconded by Mr Julian Haywood-Smith.

10. FINANCE

Mr Paul Norris pointed out that the work on the corner of Grundisburgh Road has had a detrimental visual impact on the surrounding area. The Clerk was asked to write to the Council to see if they were responsible for the work.
